



Contra Costa Environmental Health has a new process for mobile food facility permit renewals:

- You no longer need to submit an entire application packet each year.
- Complete and return the enclosed:
 - **Mobile Food Facility Health Permit – Annual Permit Renewal Checklist**
 - **Forms A & B** along with any other forms for which there are changes.
- Payments may now be made online by visiting:
<https://hsdmobile.cchealth.org/PaymentAuthorizationEx/Welcome.aspx>
- Once we receive the checklist, any changed/updated forms, the permit fee, and any other unpaid fees, you may schedule an annual permit inspection.
 - **Contact Environmental Health at (925) 608-5500 to arrange for an inspection appointment.**

The current Environmental Health Permit fees are:

- **Enclosed or Unenclosed Mobile Food Facility (MFF):** **\$896.00**
 - *Includes full preparation and limited food preparation vehicles with an extensive menu handling, preparing, and cooking potentially hazardous foods*
- **Limited Use MFF:** **\$728.00**
 - *includes coffee carts, hotdog carts, corn roaster carts, tamale carts, shaved ice carts, handling non-prepackaged foods*
- **Prepackaged, non-potentially hazardous MFF:** **\$454.00**
 - *includes pre-packaged ice cream trucks and whole uncut produce trucks*
- **Auxiliary Conveyance Unit:** **\$110.00**
- **1-4 Push Carts (price per cart):** **\$183.00**
- **5-10 Push Carts (price per cart):** **\$150.00**
- **11+ Push Carts (price per cart):** **\$137.00**

- 封閉式或非封閉式流動食品設施 (MFF) : **\$896.00**
 - 包括完整的食物準備和有限的食物準備工具，提供豐富的菜單處理、準備和烹飪有潛在危險的食物
- 有限使用 MFF : **\$728.00**
 - 包括咖啡車、熱狗車、玉米烘焙車、玉米粉蒸肉車、刨冰車、處理非預包裝食品
- 預包裝、無潛在危險的 MFF : **\$454.00**
 - 包括預包裝的霜淇淋車和未切割的整個農產品車
- 輔助輸送裝置 : **\$110.00**
- 1-4 輛車 (每車價格) : **\$183.00**
- 5-10 輛車 (每車價格) : **\$150.00**
- 11 輛及以上的車 (每車價格) : **\$137.00**
